The above recognition is subject to fulfilling of following conditions: -

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize or affiliate the school beyond Class VIII
2. The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2011 (Annexure II)
3. The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure
4. The School shall not deny admission to any child,
 - for lack of age proof
 - if such admission is sought subsequent to the extended period of ninety days for admission
 - on the ground of religion, caste or race, place of birth or any of them
5. The School shall ensure that,
 - No child admitted shall be held back in any class or expelled from school till the completion of elementary education in that school
 - No child shall be subjected to physical punishment or mental harassment
 - No child is required to pass any board examination till the completion of elementary education
 - Every child completing elementary education is awarded a certificate as laid down under rule 19 of the Right of Children to Free and Compulsory Education, Himachal Pradesh Rules, 2011,
 - Students with disabilities/special needs are given admission as per provisions of the Act
 - The teachers are recruited with minimum qualifications as laid down under section 23(1) of the Act. The current teachers who, at the commencement of this Act did not possess minimum qualifications shall acquire such minimum qualifications by March, 2015
 - The teacher performs his/her duties specified under section 24 (1) of the Act
 - The teachers shall not engage himself or herself for private teaching activities
6. The School shall follow the syllabus on the basis of curriculum laid down by academic authority under sub?section (1) of section 29
7. The School shall enroll students proportionate to the facilities available in the school specified in the section 19 of the Act.
8. The School shall maintain the standards and norms as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-
